DEAR SIR:—You recently submitted to me, through the Division of Conservation, a certain reservoir land lease, executed on behalf of the State, by J. W. Thompson, Conservation Commissioner, acting for and on behalf of the Conservation Council, by which there is leased and demised to one Lulu M. Morgan, of Lima, Ohio, a certain parcel of State Reservoir land at Lake Loramie, which parcel of land is more particularly described as being a small island in Section 1, Town 7 South, Range 4 East, in Loramie Reservoir, Shelby County, Ohio. This lease, which is one for a term of fifteen years, permits the use of said parcel of land for a cottage site and landing purposes, and the annual rental provided for therein is 6% upon the appraised value of such property, which appraised value is the sum of \$600.00.

Upon examination of the provisions of said lease, I find that same was executed by the Conservation Council pursuant to the authority of Section 472-1, General Code, and that the same is in conformity with the provisions of said section and of other sections of the General Code relating to leases of this kind.

Said lease is accordingly hereby approved by me, as to legality and form, and I have endorsed my approval upon said lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
